Sant Sar Public School, Butala, Tehsil Baba Bakala, Amritsar, under Section 18 of the Right to Free and Compulsory Education Act, 2009 and Rule 11 of the Punjab Right to Free and Compulsory Education Rules, 2011, on the basis of the post received from the authorized officers, and according to the instructions issued by Hon'ble DGSE Punjab with letter no. DGSE/RTE/2016/1276-78 dated 25-01-2016, Class Pre - Primary to Class 8 is recognized under the following conditions:-

- 1. The Organization/School will not charge any capitation fees nor will it adopt any method of turning out for the student or his parents or guardians.
- The school shall not refuse admission to any child for want of proof of birth, or if the child is approached during later extension of time for admission, or on grounds of religion/caste/place of birth or any other reason and in accordance with Section 15 of Act will follow the provisions.
- 3. No child enrolled by the school shall be kept back in class, or expelled from the school until his Preliminary Education is completed.
- 4. Physical punishment or mental distress will not be given to any child by the school.
- 5. From the school to everyone, who has received basic education, will be given certificate as per rule 21.
- 6. The school shall renew the building safety certificate, fire safety certificate and other required documents from time to time after expiry and deposit the copy in the office of the District Education Officer (Elementary Education), Amritsar. In case of failure to do so, action will be taken against the school as per RTE Act and rules regarding limitations of recognition.
- 7. The building or other structure or grounds of the school shall be used only for the purpose of educational or competency development and no unauthorized class shall be conducted inside or outside the building.

8. It is necessary for teachers to meet the educational qualifications as per

- The school will follow the instructions issued by the Education Department from time to time. Rest of the conditions will be as per temporary certificate issued earlier. The recognized code number of the school will be RTE Amritsar-01780207.

If the School/Organization is found to be in violation of any section of the RTE Act or the instructions issued by the department or if the school is seeking recognition by concealing any important fact or stating a false fact, then the recognition of the school will be cancelled.
